WWTP UPGRADES & EXPANSION IMPROVEMENTS - PHASE II
CITY OF MARYSVILLE**

Sealed proposals will be received by the City of Marysville for the WWTP Upgrades & Expansion Improvements Phase II Project, until 2:00 p.m., Local Time on Thursday, November 5, 2009, at the City of Marysville City Hall, 1111 Delaware Ave., Marysville, MI 48040, at which time and place all bids will be publicly opened and read.

Bidders shall review and comply with the Instructions to Bidders, which are incorporated by reference, and carefully review all Contract Documents, as defined in the Instructions to Bidders. Bids submitted after the exact time specified for receipt will not be considered.

The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

Description of Work

New cast-in-place concrete chemical mixing/flocculation chamber, primary clarifier with mechanisms, trickling filter with media and distribution arms, final clarifier with mechanism, new sodium bisulfite dechlorination system, new 2 million gallon cast-in-place concrete wet weather storage tank including ventilation system blowers in building and associated ductwork, new garage, new permanently mounted emergency generator, replace existing grit removal equipment, replace existing primary and final clarifiers mechanisms, replace existing trickling filters media, addition and improvements to the Main Building, improvements to the existing trickling filter recirculation system, improvements to the existing anaerobic digestion system and associated underground piping, mechanical, electrical, instrumentation, controls and SCADA systems improvements.
